Reject Globalism



INTRODUCTION:

Globalism has lifted a large portion of the world out of poverty, but it has come at a large cost and now we are living through the negative effects it has brought to our environment, local economies, politics and our overall way of life.

FACTS:

 Globalization helped lift a billion people out of poverty. China has the largest middle class in the entire world. Every year tens of millions of people get raised out of poverty in China. But at what cost?

The cost is the environmental destruction caused not only in China but on a Global Scale by their industrialization and their economic growth has resulted in a huge negative impact on the entire world.

China is bar far largest polluter on earth. China has completely destroyed entire ecosystems in it own country and is made a fair portion of their fresh water completely undrinkable.

 - In many cases these operations and policies are in direct conflict with the indigenous people's wishes for Mi'kma'ki, often they are not properly consulted beforehand.
- Globalism has brought prominence to a host of international organizations like the World Economic Forum (WEF), World Health Organization (WHO), United Nations (UN), Blackrock, Vanguard, International Monetary Fund (IMF), and the World Trade Organization to list a few. These organizations represent the financial elite and hold allegiance to no countries.
 - Ideologies like the WEFs Great Reset are dangerous. The slogan of this agenda is you will own nothing and be happy. In order for us to own nothing this means someone will have to physically take our property from us.
 - The UN, who has 60,000 troops in operation, is in cooperation with WEF and the WHO and willing to help advance and enforce their agenda.
 - Our politicians are already subscribed to globalist policies provincially and on the municipal level. For example, many towns and municipalities are bidding on grants to integrate smart technologies into our communities. This is a WEF agenda and will lead to agreements designed to trick us into their 15-minute cities and or accept their sustainable development goals.
 - Another more Dangerous example is agreements made with the WHO with regards to emergency management. Many Provinces have or are preparing to sign responsibility of managing the response of future pandemics and disasters over to this international bureaucratic organization.
 - In cooperation with a host of other bureaucratic globalist organizations they intend to or already are pushing many policies that undermine our values, traditions, freedoms and sovereignty for example Central Banking Digital Currencies, Digital ID's, Mandatory Vaccination, The New Green Agenda, Transhumanism and a lot more.

OBJECTIVES:

 - a. Legislation will make it illegal to make agreements in Nova Scotia with the WEF, WHO, or UN.
 - b. Reverse any provincial or municipal agreements made with the WEF, WHO, or UN.
- 2. Return the management of future pandemics and emergencies back to emergency management professionals in place of public health.
 - a. Dissemble Public Health.
 - i. See healthcare our policy for more info on our reasoning to dissemble public health.
- 3. Create legislation for Nova Scotia that requires and protects the individuals right to present physical non electronic ld when necessary to validate a person's Identity when accessing daily governmental or public services including international entry into Canada Via Nova Scotia.
 - i. We understand the federal government is currently assuming responsibility for this policy making and we will oppose this as it affects Nova Scotians.
- 4. Create Nova Scotia digital currency act that states:
 - a. Any provincial currency that is intended to be Nova Scotia's official main circulated currency is required to have at minimum a physical counterpart.
 - b. Any official currency Nova Scotia adopts in the future must have no restrictions on its use and restrictions can not be placed on it due to personal habits or opinions of an individual.

- 5. The current Emergencies Act has been written with the advice from the WHO, WEF, and other corrupt organizations. This act needs to be reversed or abolished and re-written by Nova Scotians.
- Make investments in proven companies that are willing to expand into Nova Scotia that produce critical life saving medicine, medical devices or nutrient dense organic wholefoods.
 - a. Offer these companies willing to expand into Nova Scotia Loans with 0% interest.
- 7. Evaluate all current contracts to extract natural resources and disclose this information to Nova Scotians.
 - a. Disclose the environmental impact to Nova Scotians for each potential permit.
 - Disclose how many jobs each contract provides Nova Scotians and how much estimated overall revenue said contract will generate for the province.
 - c. Let the people decide through referendums the criteria for all future contracts and permits to extract or harvest natural resources.
